

The Council has been asked to address this in the media to ensure compliance with the barrier. It is only a matter of time before a new bridge will be installed. Funding has been secured for the work, but prices are needed from contractors in order to choose who will carry out the work. 1.5	Parking at Nant Peris and A4086 - a verbal report was presented by several councillors regarding the parking that had existed over the Easter holidays. The matter was discussed in detail, leading to the following decisions: · To apply to Gwynedd Council for details of the existing clearway on the road and whether it continues. · To complain to Gwynedd Council about the lack of enforcement. · To request Gwynedd Council to close the lay-by opposite Bens which is not a designated parking location due to the absence of dropped curbs. The Council believes it is a viewpoint. · The above lay-by is being used for overnight stays which results in litter and human waste being left behind its wall. · Invite an officer to come and speak to the community council about Gwynedd Council's vision for the ongoing parking issues.
