

4.3	Street Sculpture/Memorial to Quarrymen - There has been no development on the matter recently. Gwynedd Council Officers are looking at other locations.	CLERK

4.7	Bylaws - it was said that the Clerk had done more research to present bylaws. One Voice was of the opinion that this was possible but that enforcement was difficult and in many cases the enforcement service had to be purchased by the local authority. In the case of lay-bys on the A4086 which are owned by Gwynedd Council, this would mean that the Community Council would be paying Gwynedd Council to enforce on their own lay-bys. It was decided to monitor the lay-bys and take photos to gather evidence of the problem in order to send again to Gwynedd Council.	CLERK
4.8	Walls up to the pass - there has been no continuation so far. Work is hoped to be done in the spring. Due to the severe weather over the winter, it is not safe for workers to work on the walls.	GTE

4.10	Salt Bins - these have not been moved so far. Councillor Llinos Pritchard stated that the salt bin on the way to her house is located in an inconvenient spot and moving it up the hill would be more ideal. Arrangements are to be made for its relocation.
