

1.1	No public participation	
1.2	In order to ensure that the Council can provide a bilingual service to voters, it is necessary to translate most of the Council's policies into English. A cost estimate was obtained for how much these would cost, and due to the cost size, it was decided that the Council would not translate documents from the past, but if someone requests a copy of a specific policy in English, then that relevant copy will be translated at that time. Every policy going forward will be presented in both languages.	
1.3	Following a special meeting between the Llanberis Development Group and the Community Council with guests from Menter Stiniog, it was decided to establish a Group to look at how to create a Llanberis enterprise/partnership. First, an activity will be needed to engage with the public. The Clerk will arrange this for the website, Facebook page, and also at the Summer Community event. 5.8	Coed Doctor - it has been reported that money has been allocated for a new bridge in Coed Doctor and it is hoped that work will begin very soon.
