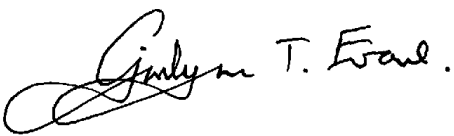

1.	CHAIRMAN'S OPENING REMARKS AND APOLOGIES	
	Agorwyd y cyfarfod yn ffurfiol gan y Cynghorydd Beth Holding yn absenoldeb y Cadeirydd. Derbyniwyd ymddiheuriadau oddi wrth y canlynol, Cynghorydd Llinos Pritchard, Louise Price a Trystan Thomas.	CLERK
1.1	Ni chafwyd cyfranogiad gan y cyhoedd.	
1.2	Cyflwyniad gan Heddlu Gogledd Cymru Croesawyd PC Siwan Humphreys a PCO Nia Roberts i'r cyfarfod misol. Roedd swyddogion yr heddlu yn awyddus i drafod y mater o gyflwyno camerâu cylch cyfyng o fewn y pentref. Dywedodd 277 achos o droseddau a 86 achosion o wyth gymdeithasol wedi digwydd yn Llanberis o fewn y 2 flynedd diwethaf. Roedd yr heddwes wedi dadansoddi'r ystadegau ac roedd yn gallu dangos ar gynllun lle'r oedd y mwyafrif wedi cymryd lle. Nid yw'r heddlu yn gallu bod yn bresennol pob dydd a thrwy'r dydd felly mae cyflwyno camerâu ar y stryd yn dechlyn sydd yn gallu eu cynorthwyo i ddal y tramgwyddwyr. Mae Cyngor Gwynedd (Partneriaeth Cymunedau) a'r Heddlu o'r farn byddai cyflwyno camerâu o fudd i'r ardal ond yn anffodus nid oes cyllid ar gael ar gyfer eu prynu. Rhagwelir bod angen 15 camera ar gost o £40,000. Mae polion goleuadau sy'n bodoli o fewn y pentref yn addas ar gyfer gosod y camerâu. Bydd angen cael lleoliad ar gyfer yr hwb - Y Cyngor i wneud cais i Bwyllgor y Ganolfan os fydd yn bosib gosod yr hwn yn y Ganolfan. Bydd angen dod o hyd i grantiau ar gyfer gosod y camerâu. Bydd y Clerc a'r heddweision yn gweithredu a'i gilydd i ddod o hyd i'r grantiau. Y Clerc i wneud ymgynghoriad a National Grid a First Hydro. Yr heddwes i edrych i mewn os oes cyllid i gael oddi wrth gronfa Comisiynydd yr Heddlu. Diolchwyd i'r ddwy heddwes am eu hymweliad.	CLERK
1.3	Ultra Trail - daeth cyfarwyddwr yr achlysur Hayden Arrowsmith i ymweld â'r Cyngor Cymuned er mwyn cyflwyno ei hun ac i ddangos ei fod eisiau cyd-weithio er budd y gymuned. Dywedodd Mr Arrowsmith ei fod eisiau sicrhau bod budd tymor hir i'r pentref o'r achlysur. Bydd yr achlysur yn 2025 yn digwydd ar y 16 o Fai wythnos wedi'r Wyl fwyd yng Nghaernarfon. Mae yn gobeithio trefnu teithiau bws o'r Orsaf Rheilffordd ym Mangor er	

	mwyn trio lleihau'r effaith a'r Lanberis. Fe drafodwyd Glyn Rhonwy fel man parcio a'r diffyg o dderbyn cadarnhad cael defnydd lleoliad gan Gyngor Gwynedd. Mae pentref yr Ultra Trail yn gyfle arbennig i fusnesau'r pentref a'r ardal gyfagos i godi stondin. Mae trefnwyd yn awyddus i gysylltu â gwirfoddolwyr lleol - dywedodd y Cyngor y byddent yn rhoi gwybodaeth i gyrff a fyddai yn gallu helpu. Maent hefyd eisiau cychwyn rhaglen llysgenhaddon o Lanberis er mwyn ddod yn gynrychiolwyr lleol ac yn wyneb lleol i'r achlysur. 3.1	The expenditure and financial report for septemebr 2024 were presented and accepted.	
4.0	CONFIRMATION OF LAST MONTHS MINUTES AND MATTERS ARISING	
4.1	Minutes for septemebr were confirmed.	
4.2	Litter bins for Cae Chware Lan Llyn - still waiting for Gwynedd Council to deliver a bin. The Clerk also said that bins will be provided in the area as part of the improvements to the World Heritage Slate Site.	
4.3	Street Sculpture / Quarrymen's Memorial - the Clerk stated that a meeting had taken place regarding the sculpture. A proposed location has been determined, namely the area near the junction of High Street and the bypass. The Sculpture will be approximately 4.6 meters tall and as a result, planning permission will be required. It is hoped to receive the permission within 8 weeks after the statutory consultation and consideration of the consultation responses. In the meantime, a response is needed from the Council and local people before the planning application. The	CLERK

	Council decided to support the application. The Clerk also mentioned that she had made inquiries with Zurich, the Council's insurers, and that they need to see the planning application before making a final decision; they stated that they insure sculptures of this type but possibly with conditions depending on the structure, etc. As part of the planning application, it must be shown that the Council is prepared to implement measures to reduce the impact of the sculpture on the environment. It was decided that the Council would provide bat boxes and a section on nearby trees. Once the sculpture is completed. The council needs to adopt the sculpture as an asset. The council showed agreement to do this.	
4.4	HBO Panel - the application acceptance period remains open until December 1st, 2024.	CLERK
4.5	Outdoor Gym - the council has successfully applied for a grant in principle. The Clerk will move forward to obtain further information from Gwynedd Council before the work can proceed.	CLERK
4.6	Menter/Partnership Llanberis Partnership Dyffryn Peris - it is hoped to hold a meeting for associations and bodies within the community to discuss creating a partnership at the beginning of the new year.	RhaG/CLERK
4.7	Toilets - the clerk explained that there was no information or evidence that the Council received 10% of the profit from the Gwynedd Council car park and that it was being used for the costs of the toilets. An invoice of £12,000 has been received this year. The invoice was £6,000 last year. The matter was discussed. It was decided that the Council would pay £6,000 as last year because there was no notice from Gwynedd Council that there was no discount this year.	CLERK
4.8	Sheep and persistent weeds - the Clerk stated that she had made inquiries regarding how to deal with this problem. She had been in contact with the Farmers' Union, the Ministry of Agriculture, and Gwynedd Council. She is expecting a call from a Trade Standards officer to call her back. From what she has learned, it is possible to keep the sheep for 14 days, notify the farmers that the sheep have been kept, and if they are not collected within the specified period, the Council then has the right to sell them. Unfortunately, this is not practical for the Council. There is evidence to show that this problem has existed in the village since the 1920s.	
4.9	Walls up to the pass - no response from the National Park. Roads have requested an inspection by the road inspector.	
4.10	Camping in unsuitable places - there has been no response from Cadw.
